**New Utility Billing System**

The City of Sutton has upgraded our Utility Billing System. Below is an example of the new Utility Bill. To sign up and view your bill, click on **View E-Bills** on the City of Sutton Website, [cityofsutton.org](http://cityofsutton.org). Click on **Learn How to Register** for step by step instructions in how to register your account. This portal will only be used to view your bill not pay it. You will continue to use Bill Payment for payment of your bill with a credit card. Once your account is registered, you can add your account (accounts) that you would like to view for the following month. With your paper bill in hand, enter the appropriate information. The account number must have the hyphen in order to recognize your account as shown below on the example bill. In order to view your March bill, your account/ accounts must be registered and entered by February 25th.
