Community Center Rules & Regulations

Just a friendly reminder for all walking key holders & renters.

- ◆ The owner of the key **must** be present at all times. **Do not** loan your key out to others.
- ◆ An adult must be present with persons under 19 years of age.
- ◆ Turn off all lights in restrooms, kitchen, gym and front carpeted area of building prior to leaving building.
- ◆ Clean up all messes & take out all trash prior to leaving building.
- ◆ Lock all doors prior to leaving building. This is your responsibility.

New Utility Billing System

The City of Sutton has upgraded our Utility Billing System. Below is an example of the new Utility Bill. To sign up and view your bill, click on **View E-Bills** on the City of Sutton Website, cityofsutton.org. Click on **Learn How to Register** for step by step instructions in how to register your account. This portal will only be used to view your bill not pay it. You will continue to use Bill Payment for payment of your bill with a credit card. Once your account is registered, you can add your account(s) that you would like to view for the following month. With your paper bill in hand, enter the appropriate information. The account number must have the hyphen in order to recognize your account as shown below on the example bill. In order to view your April bill, your account(s) must be registered and entered by March 25th.
