## Sutton Foot Clinic

The Clay County Health Department sponsors a Foot Clinic in Sutton the 4th Thursday of each month. The clinic is open to all seniors and is operated on a first come, first served basis. There is a \$10 fee to help cover the cost of supplies. During the clinic, the feet are soaked in warm water for 5-10 minutes, an assessment is done, nails are trimmed and filed, and lotion is applied to the feet. For those who can't make it to the clinic in Sutton, foot care is provided in Clay Center on an appointment basis. For more information, call the Clay County Health Department at (402) 762-3571.



## ATVs

In order to drive an ATV/Utility Vehicle on the streets of Sutton you have to have a license that can be renewed yearly at City Hall for \$10. Please see City Ordinance for full rules and regulations. In order for City Hall to issue you a license for your ATV:

- You must be 21 years of age or old
- You must possess a valid drivers license
- You must maintain liability insurance on all licensed ATV/Utility Vehicles
- You must have working headlights & taillights
- You must have an OEM Muffler
- You must have a federally approved flag.

ATV's may be operated only between the hours of sunrise and sunset. Utility Vehicle speed should not exceed 30 miles per hour.

**SCAMS– know who you are giving your personal information to.**

We certainly understand if the latest IRS imposter scam makes you queasy: it involves a fake IRS tax notice that claims you owe money as a result of the Affordable Care Act. It's one of many IRS imposter scams that have popped up. As tax season nears, we'll see more. The good news? There are red-flag warnings that can help you avoid becoming a victim. For example, the IRS will never:

- Initiate contact with you by email or through social media.
- Ask you to pay using a gift card, pre-paid debit card, or wire transfer.
- Request personal or financial information by email, texts, or social media.
- Threaten to immediately have you arrested or deported for not paying.

**Ambulance Rates**

Sutton Ambulance Service provides the Sutton area with Basic Life Support Emergency Medical Services and Transport. Our trained volunteer EMT's and EMR's dedicate their time and service to help save lives. At the last Sutton City Council meeting Resolution 2016-9 was approved to update the current ambulance rates. As of December 12, 2016 the new ambulance rates are as follows:

- Basic Life Support Transport \$450.00
- Basic Life Support Non Transport or Lift Assists \$125.00
- Basic Life Support Non Transport or Lift Assists - Assisted Living Facility and Nursing home \$225.00
- Mileage \$12.00 per mile
